Board Minutes

PVOA Board of Directors Meeting Unapproved Minutes - July 12, 2017

The July meeting was called to order by President Mike Wright at 7:02 PM. Board members in attendance: Mike Wright, Kurt Proctor, Jeff Wolf, Dale Lindle, David Krzyzanowski and Linda Peterkin. Also in attendance were Deanna Nielsen, clerk, and 4 residents.

Approval of minutes and Treasurer's

Report: The motions were supported and passed. Because there was no quorum in June, no official minutes were recorded.

Open to the Floor:

A resident expressed his concerns of a maintenance man driving a mower too fast which was unsafe for him and the equipment. He also noted that one of the new houses on Hillside Drive doesn't have grass yet and stated a board member should check with the owner. Also he questioned if new owners are given a blue book. Residents are given a copy of the blue book if requested.

A resident complained about the water caps on sidewalks being a tripping hazard. He was instructed to follow up at the Park View Water Company's meeting next week. He also reiterated that he had seen the maintenance man driving the mower too fast.

Committee Reports:

Legal: Linda reported that the annual dues have not increased with inflation. With additional funds PVOA could contract to have additional policing of the area and update more playground equipment. Linda made a motion to have a special meeting on October 11 to discuss increasing the rates. Jeff seconded. Linda contacted the lawyer about the process of increasing the annual dues. Written notice must be sent to all members at least 30 days in advance. A quorum (60% of all votes) must be present in order to vote. If there is not a quorum, then a second meeting must be held within 60 days. The change would need be approved by twothirds of the votes. The motion was supported and passed. (Editor's note: After receiving written instructions from the lawyer, the board has decided to wait until January 2018 to start the process.)

Insurance: Kurt reported the Management Liability Policy was paid.

Park Board: David reported the organization is looking for a T-ball coordinator for next year.

Architectural Control: Since the position is vacant, Mike and Kurt have approved several requests in the past month.

Maintenance Control: 1) Mike reported that Sam Yarham has been hired as a maintenance man and started last week. 2) Supplies have been purchased and the work has started on the sidewalk/culvert project behind Deer Creek Apartments.

Office Activities: With the office manager board position open, Deanna reported: 1) Liens have been placed on 8 homes and 4 apartment complexes (38 units) for nonpayment of 2017 dues. 2) Matching funds from the Moonlight Chase Grant has been deposited. The playground equipment should arrive soon. 3) Julie Peterson cleaned the building today. 4) The webpage and Facebook page have been updated. 5) Mike will check the mail and answering machine while Deanna is on vacation.

Parkway Development: Position is open but Mike noted that someone needs to select locations for the new equipment.

Old Business:

4th of July/ 50th Celebration: A small group of volunteers organized the event. Comments about the celebration: 1) parade route might need to be changed but was just the right length 2) expand the car show 3) the band was a hit 4) overall great event! T-shirt sales will continue during regular office hours and during the Fall Garage Sale Day. The history boards will be on display in the PVOA building. Kurt made a motion to donate the same amount as last year to the Scott County Sheriff Reserve and the Long Grove Fire Department. (\$400 to Sherriff \$250 to LGFD) Jeff seconded. The motion was supported and passed.

Appointment of Board Member – David made a motion to appoint Justin Norwood to the board. Dale seconded. All in favor, motion carried. Board members welcomed Justin.


